

## Rules and Regulations for sport events at stadium MSK Zilina a.s.

## Article I Basic provisions

- Football club MSK Zilina, a.s., Športová ulica 9, Zilina, ID 364 19 320 (hereinafter referred to as the "organiser") issues, pursuant to Act no. 1/2014 Col. on the organization of public sports events and on the amendments and additions of certain laws, these Rules and Regulations at the Sporting Event (hereinafter referred to as the "Rules and Regulations"), which refers to football matches (hereinafter "event") organized by the organiser of the sports facility - Stadium MŠK Zilina, Športová ulica 9, 010 01 Zilina (hereinafter referred to as "sports facility").
- Participant in the event is mainly a spectator (visitor), journalist, photographer, 2. TV crew member, radio or other electronic media employee, member of the sports team, member of the technical team, bartender or other person assisting at the course of the sporting event.
- A member of the organizing staff (hereinafter referred to as the organiser) is a 3. person dressed in a reflective vest or reflective uniform with a distinctive inscription "USPORIADATEL" and a number on the front and back of the vest. For UEFA and FIFA competitions, including international and inter-state events, it may be marked with a different inscription, usually in foreign language.
- 4, The purpose of these Rules and Regulations is to ensure the safety, health and property protection of participants and the protection of the sporting equipment and property of the sports facility.
- 5. The Rules and Regulations set out binding rules for participants' behavior at the event.
- 6. Every participant in the event is required to comply with the obligations, guidelines and regulations
- stated in these Rules and Regulations, a)
- mentioned on the ticket or in the information leaflet issued for the event, b)
- safety marking in a sports facility, c)
- members of the organizing staff, members of the private security service, Police Force officers who ensure the protection of public order at the event and member of the supervisory body,

- e) members of the medical rescue service, fire brigades and other rescue services, and to comply with the provisions of Act no. 1/2014 Col. on the organization of public sport events and on the amendment of some laws and other legislation of the Slovak Republic.
- 7. Participants take part in the event at their own risk.
- 8. The participant undertakes to observe these Rules and Regulations, enters into a contractual relationship with the organizer of the event and expressly agrees to the application of possible sanctions by the organizer towards the participant resulting from possible unlawful behavior of the participant.
- 9. The organiser of the event is responsible for injury and damage to the property caused to participants only if they were caused by non-observance of the laws of the Slovak Republic by the organiser of the event, intentional or negligent acts of persons who are in an employment or other contractual relationship with the organiser of the event; the participant of the event of the event has notified the organiser of the event in writing within 15 days of the occurrence of the incident.

# Article II Rights of the organiser

The organiser is authorized to:

- a) make sure that the event is intended to be attended only by a person entitled to it, and for that purpose, to require the identity of the participant to be demonstrated,
- b) check by visual, tactile or technical means, if a person entering the premises of the sports facility where the event is held does not carry, including the hand luggage, a pyrotechnic product, a firearm, a cold weapon, or other object which may be used to make a stronger attack onto the body, alcoholic beverages, drugs or other narcotics,
- c) not allow or prevent entry to an event to person who brings a pyrotechnic product, a firearm, a cold weapon, or a different weapon which may be used to make a stronger attack onto the body, alcoholic beverages, drugs or other narcotics,
- d) to prevent entry or to stop entry to an event to a person apparently under the influence of alcohol, drugs or other narcotic drugs,
- e) not allow entry to an event to a person who was imposed by court a limitation on probation supervision or has been imposed a restrictive measure by a competent authority,
- f) not allow entry to an event to a person who does not show his or her identity in good faith, if he/she was requested to do so,

- not allow entry to an event to a person who is reasonably suspected to violate the public policy or to interfere with the peaceful conduct of the event,
- not allow entry to an event to a person under 14 years of age without being accompanied by an adult person if there is a risky event,
- to warn the participants of the event concerning the inappropriateness of their behavior and to require them to abandon it, if they violate public policy or disturb the peaceful conduct of the event,
- to ask participants to leave the event without compensation for admissions, if they continue to act inappropriately after being warned, if they violate public order or interfere with the peaceful conduct of the event,
- to escort participants of the event and to stop their attendance of event without compensation for entry if they did not obey the request to leave the event,
- to request from a person who carries pyrotechnics products to the event, a firearm, a cold weapon, or any other object that can make a more violent attack onto the body, alcoholic beverages, drugs, or other narcotic substances to show his or her personal data - name, surname, date of birth, permanent residence - required for the registration of persons in the information system on safety in sports events pursuant to S 22 of Act no. 1/2014 Col. on the organization of public sports events and on the additions and amendments of some laws.
- to ask the participant who was expelled by the organiser of the event and was banned from attending the event in order to provide his / her personal data - name. surname, date of birth, permanent residence - necessary for the registration of individuals in the information system on safety at sport events according to Section 22 of Act No. 1/2014 Col. on the organization of public sports events and on the additions and amendments of some laws.
- to use for the purposes of performing organiser's tasks an record from the register in the information system pursuant to S 22 of Act no. 1/2014 Col. on the organization of public sports events and on the additions and amendments of some laws.

#### Article III

Obligations and prohibitions for the participant of the

event 1. Participant of the event is required

to observe the instructions of the organiser of the event, the organizing staff, Police Force officers and members of the private security service to ensure the protection of public order at the event and to abstain from anything that would violate public order or orderly and peaceful conduct of the event,

- b) refrain from consuming alcoholic beverages during UEFA and FIFA events including all international and inter-state events as well as events marked by the event organiser as risky unless the organiser specifies otherwise,
- c) to refrain from taking drugs and other narcotics during all sports events,
- d) to bear the actions of the organiser or member of the private security service related to breach of the obligations of the participant,
- e) to leave the venue after the event,
- f) to obtain a ticket to a sector dedicated to fans supporting the team, which he also supports in the event of a risky event or event on which the tickets were issued with a name and surname,
- g) when requested by the organiser to provide his / her personal data name, surname, date of birth, permanent residence necessary for the registration of natural persons in the information system on safety at sporting events pursuant to S 22 of Act no. 1/2014 Col. organizing public sports events and amending certain laws in the following cases:
- if he/she brings a firearm, a cold weapon, a pyrotechnic product, or another thing that can make a stronger attack on the body, alcoholic beverages, drugs or other narcotics.
- if the person was escorted out of the event and was denied further participation in the event.
- 2. A visiting person is forbidden to bring to the event:
- a) firearms and other weapons and objects which may be more harmful (e.g. daggers, cords, bayonets, knives, sticks, bars, batons, glass bottles, chairs, stands), excluding items approved by the organiser,
- b) explosives and pyrotechnic products,
- c) sprays, corrosive, flammable and colouring agents or other harmful substances,
- d) alcoholic beverages, drugs or other narcotics,
- e) state symbols of foreign states or their predecessors,
- f) racist, vulgar, defamatory and banners contradicting good morals, leaflets and other similar materials.
- g) mechanically driven machines and tools causing noise,
- h) animals/pets,
- i) laser pointers and other objects whose light and other radiation negatively affect participants in the event, including athletes and referees,
- i) audio and video recorders.

- 3. Participant of the event is forbidden:
- a) to have a face hidden in the premises and adjacent areas of the sport facility in a way that makes it impossible to identify him/her,
- b) to use state symbols of foreign states or their predecessors in a detrimental manner or in any other way that may incite to violation of public order or jeopardize the proper conduct of the event,
- c) to say and chant racist, vulgar, abusive and immoral words and passwords,
- d) to enter the premises of a sports facility that is not intended for the spectator (s) of the event, for example, in the playing area, to the spaces designated for the athletes, members of the teams of the athletes, referees, delegates,
- e) to throw objects into the sports facilities threatening the health and safety of participants of the event,
- f) to set fire and use pyrotechnic products in a sports facility,
- g) to incite public offense,
- h) to pollute sports facilities by poster decorations, commercial, non-commercial and advertising announcements,
- i) to destroy and damage the sports facility and its equipment,
- j) to harass and physically attack and beat the participants of the event,
- k) to sell goods and services without the permission of the organiser of the event,
- to make and make available to the public the audio, video and audio-visual recordings in the stadium areas. The facts stated in the preceding sentence do not apply to the participant of the League Club, with the registered office: Tomášikova 30C, 821 01 Bratislava Ružinov as the administrator of broadcasting and other rights to the Niké league, granted the prior written consent to produce and make available audio, video and audio-visual recordings public. By buying a ticket, the visitor undertakes that audio, video or audio recordings from Niké League matches will not be used for media or commercial purposes or otherwise disclosed without the prior written permission of the LCU. Proceedings in violation of this paragraph are considered to be a violation of the Rules and Regulations, with which the associated LCU can claim damages in case of its occurrence as well as the organizer's ability to record the participant in the information system on safety at sport events pursuant to S 22 par. (1) i) of Act no. 1/2014 Col. on the organization of public sports events in the current version.
- m) to use any devices for collecting fast betting data for unauthorized entities.

- 4. The following are prohibited in the premises of the sports facility accessible to participants:
- a) to sell and serve alcoholic beverages, excluding VIP and Business boxes. During two highest competitions that are not marked as risky, there is possibility to sell alcoholic beverages with alcohol content up to 4.1 % alcohol volume present, if the municipality has not issued a ban on the sale, supply or consumption of alcoholic beverages.
- b) to smoke, except for places designated and marked as such.

#### Article IV

Entry and stay of the participant at the event

- 1 Only a person who shows a valid ticket or other document (e.g. a card) entitling him/her to enter the event in the sports facility in which the event takes place.
- 2. At the request of a member of the organising staff, a member of a private security service, or a member of the Police Force, who provide for the protection of public order at an event, the participant is obliged to provide at any time a ticket or other document (e.g. a card) authorising him / her to enter the event. If the person has no valid ticket or other document, he/she is obliged to leave the sports facility in which the event takes place. If he does not do so, he can be escorted out of the event.
- 3. The participant is obliged to watch the event from the specific place (seat) which is written in the ticket or other document issued by the organiser of the event.
- 4. Only one participant (one person) may sit in one seat regardless of age.
- 5. The organiser shall provide to physically disabled participants seamless access to a reserved seat with assistance provided by a member of organiser's staff.
- 6. The participant shall not unreasonably stay in the communication areas of a sports facility such as: entrance staircases, staircases, escape areas and zones, gates, corridors and restrooms during the event.
- 7. The participant of the event may not stay in the other sector (Press, VIP, etc.) during the course of the event than the one on the ticket or other document which is issued by the organiser of the event.

- In the immediate vicinity of the playing area (between the fence and playing area), in addition to players, members of sports teams and referees, entry and stay are permitted only to:
- Security Manager of MŠK Zilina
- Main organiser MSK Zilina
- Appointed organising staff
- Appointed members of Security Company
- Technical department staff responsible for the maintenance of the pitch and the stadium appointed for the event by the Main organiser. - Ball boys
- MŠK Zilina Cameraman
- Fire Patrol, members of Fire Department Medical teams
- Photo reporters accredited for the event (marked with yellow vests with PHOTO)
- TV staff directly providing the production of the TV signal
- Other persons with special ALL ACCESS accreditation issued exclusively by MŠK Žilina

### Article V

General rules for using one-time tickets, permanent tickets and club cards

- A one-time ticket, permanent ticket, and club card are issued for the person's 1. name.
- A one-time ticket, permanent ticket and club card are not transferable. The holder of a one-time ticket, permanent ticket and club card is responsible for any violation of these Rules and Regulations or other legal duty by the person to whom he/she borrowed, sold or otherwise provided the card.
- In case of loss or theft of a one-time ticket, a permanent ticket and a club card, the holder is obliged to notify the organiser of this fact, otherwise he/she is responsible for their misuse.
- A one-time ticket entitles the holder to a one-time entry to the event written in the one-time ticket.
- A permanent ticket entitles the holder to enter events organised by the organiser.

- 6. The Club Card entitles the holder to purchase one-time tickets for events appointed by the organiser and to use benefits provided by the organiser.
- 7. In the event of cancellation of the event, the organiser shall notify the venue at the place of purchase of the ticket with an alternate date of the event or way of returning the entry fee.
- 8. When issuing and using one-time and permanent children's tickets, the administrator and organiser are entitled to check the health insurance ID of the individual to whom a one-time and permanent ticket shall be issued, or a person who uses the one-time and permanent children's ticket to enter the event.
- 9. The organiser is entitled, without compensation, to cancel the validity of the permanent ticket and the club card to the holder who has violated these Rules and Regulations or was expelled from the event.
- 10. There is no legal claim to buy a one-time ticket, permanent ticket and club card, the organiser reserves the option of not selling a one-time ticket, permanent ticket and club card to a person or legal entity without giving any reason.
- 11. Other conditions of sale and use of one-time tickets, permanent tickets and club cards are published by the organiser in the usual way, especially on the official website of the organiser (www.mskzilina.sk), the official website of the seller (www.ticketportal.sk) as well as at the points of sale.

#### Article VI

### Escorting the participant out of the event

A member of the organizing service, a member of the private security service, or a member of the Police Force, who provide for the protection of public order at an event, may, without refunding the entry fee, expel from the event of a participant who:

- a) does not observe the instructions of the organiser of the event, the organizing staff, officers of the Police Force and members of the private security service ensuring the protection of public order at an event,
- b) violates the public order or the orderly and peaceful course of the event,
- c) violates applicable laws of the Slovak Republic and the relevant regulations, directives and regulations of the Slovak Football Association, Union of Leagues, UEFA and FIFA.
- d) drinks alcoholic beverages during an event on which it is forbidden,
- e) using drugs and other narcotics during the event,

- has in the premises and adjacent spaces of the sports facility a face covered in a way that makes it impossible to identify him/her,
- uses state symbols of foreign states or their predecessors in a detrimental or other way that may incite to violate of public order or to jeopardize the proper conduct of the event.
- h) says and raises racist, vulgar, defamatory and immoral words and passwords, respectively, presents them on banners, posters, and the like
- enters the premises of a sports facility not intended for the spectator (s) of the i) event, for example in the playing area, in the premises designated for competing athletes, members of teams of athletes, referees, delegates, officials,
- throwing into the premises of the sports equipment objects threatening the health and safety of the participants of the event,
- k) starts fires and uses pyrotechnic objects in a sports facility,
- I) awakens public offense,
- polluting sports facilities (including poster decoration, commercial, noncommercial and advertising),
- destroys and damages the sporting facility and its equipment, n)
- harasses and physically assaults and beats participants of the event, 0)
- sells goods and services without the permission of the organiser of the event, p)
- does not observe the ban on smoking within sports facilities. q)

## Article VII Sanctions

- The organiser is entitled to penalize the participant who has breached the Rules and Regulations according to valid legal statute of the Slovak Republic, in particular to claim against the participant the claim for damages consisting in the reduction of the organizer's property in the form of fines paid by the competent authorities of the municipality, state, SFA, LCU, UEFA and FIFA, compensation for other property and non-pecuniary damages caused by violation of the legal obligations of the participant and prohibiting the participant from attending events organised by the organiser.
- The person who has been convicted of a violation of a legal duty by an organization responsible for the offense for which the organiser has been

sanctioned by the competent authorities of the municipality, state, SFA, LCU, UEFA and FIFA is responsible for the full penalty and undertakes to pay it to the organiser 15 days from the date of the force of the decision by competent authority.
